Stock futures were little changed on Wednesday night after the Dow posted its best day since April 2025 following a ceasefire deal. The Nasdaq, S&P 500, and Dow Jones advanced 2.8%, 2.5%, and 2.8%, respectively (Source: CNBC)
- European Stocks Soar on Bullish Sentiment**
European stocks rose sharply on Wednesday as eased geopolitical tensions, falling oil prices, and lower bond yields drove sustained buying and a bullish market mood; the FTSE 100, CAC 40, and DAX advanced 2.5%, 4.5%, and 5.1%, respectively (Source: CNBC).
- Asia Markets Fall on Ceasefire Doubts**
Asia-Pacific markets traded lower on Thursday morning as investors fretted over news that Iran's parliamentary speaker charged the U.S. with breaching ceasefire terms (Source: CNBC).

On Wednesday, the TASI advanced 2.27% to close at 11,339.00. Out of the 21 sectors, 1 finished in the red; gains were led by Media and Entertainment (+6.73%) and Utilities (+5.61%), while Energy (-1.86%) was the only laggard. Market breadth was strong, with 256 gainers vs. 11 losers, and daily turnover reached SAR 8.4bn.

• Jarir Opens New Kuwait Showroom

Jarir Marketing Company opened a new SAR 15mn showroom in Kuwait's The Gate Mall to replace its Sama Mall location (Source: Tadawul).

• Saudi Azm Wins Council Project

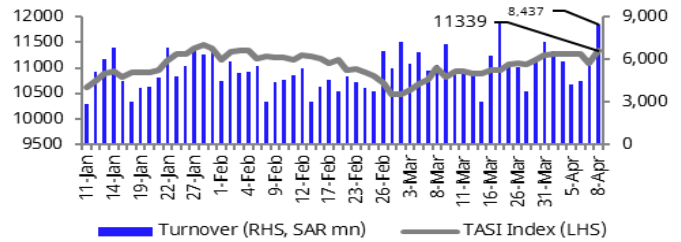

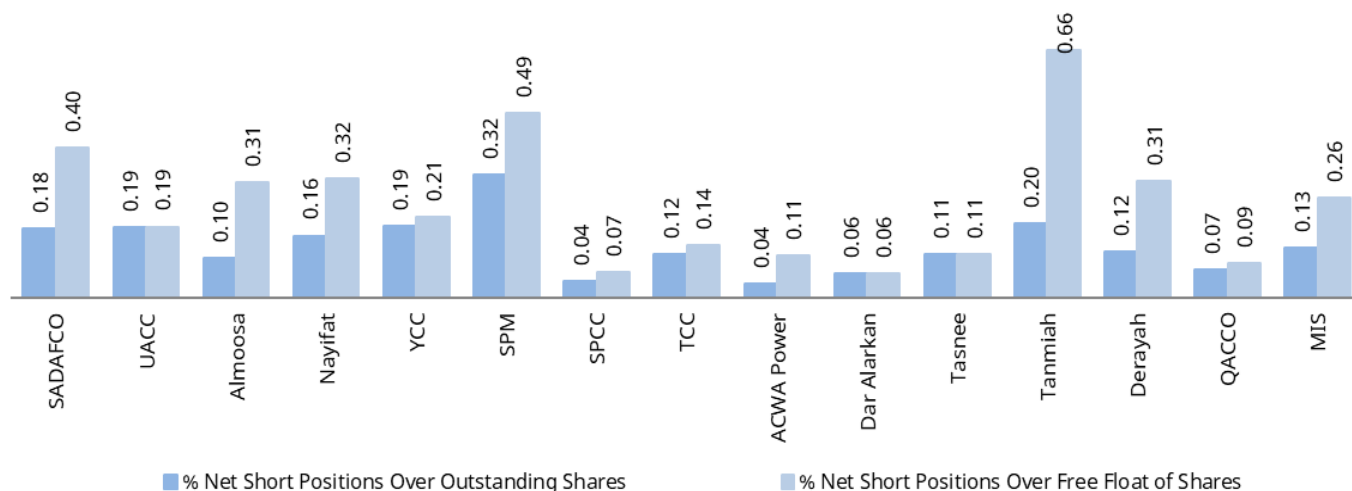
